

March 06, 2023 NOTICE OF SOURCE MATERIALS FOR PROMOTIONAL EXAMINTION IN THE GEORGETOWN FIRE DEPARTMENT POSTION: DEPUTY FIRE MARSHAL

In accordance with Local Government Code Section 143.029, all promotional examination questions must be taken from sources that are listed in a notice that is posted by the Civil Service Commission least ninety (90) days before the date of the examination. This list includes all the sources that will be utilized for the promotional examination for the position of Deputy Fire Marshal. This list will be posted permanently but may be revised from time to time to include new sources and/or delete sources that are out-of-date.

Also in accordance with Local Government Code Section 143.029, before the 30th day that a promotional examination is held, the Commission shall post a notice which shows the position to be filled or for which the examination is to be held, and the date, time, and place of the examination.
